## **CU Inc. Eligible Dividend**

CALGARY, Alberta – The Board of Directors of CU Inc. has declared a quarterly dividend of 0.2875 cents per 4.60% Cumulative Redeemable Preferred Share Series 1 (TSX Stock Symbol: CIU.PR.A). The dividend is payable on March 1, 2008 to shareholders of record on February 6, 2008. This dividend is an eligible dividend for Canadian income tax purposes.

CU Inc. is a wholly owned subsidiary of Canadian Utilities Limited, part of the ATCO Group of companies. CU Inc. is an Alberta based corporation with assets of approximately \$4.7 billion and more than 3,700 employees and is comprised of two main business segments: Utilities (natural gas and electricity transmission and distribution) and Power Generation.
