CALGARY, Alberta – The Board of Directors of CU Inc. has declared a quarterly dividend of 28.75 cents per 4.60% Cumulative Redeemable Preferred Share Series 1 (TSX Stock Symbol: CIU.PR.A). The dividend is payable on March 1, 2009 to shareholders of record on February 6, 2009. This dividend is an eligible dividend for Canadian income tax purposes.

CU Inc. is a wholly owned subsidiary of Canadian Utilities Limited, part of the ATCO Group of Companies. CU Inc. is an Alberta-based corporation with assets of approximately \$5.3 billion and more than 3,700 employees and is comprised of two main business divisions: Utilities (natural gas and electricity transmission and distribution) and Power Generation.
