## **CU Inc. Eligible Dividend**

CALGARY, Alberta – The Board of Directors of CU Inc. has declared a quarterly dividend of 0.2875 cents per 4.60% Cumulative Redeemable Preferred Share Series 1 (TSX Stock Symbol: CIU.PR.A). The dividend is payable on September 1, 2007 to shareholders of record on August 8, 2007. This dividend is an eligible dividend for Canadian income tax purposes.

CU Inc. is a wholly owned subsidiary of Canadian Utilities Limited, part of the ATCO Group of Companies.
